2022 ACL Conference In-Person Participation Refund Policy*

The 2022 ACL Annual Conference will be June 13-15, both in-person at Newman University in Wichita, KS and online through the Whova online platform. **This refund policy pertains to those who register to participate in-person in Wichita, KS.** In addition to the in-person conference programming, registrants will have access to 10 pre-recorded workshops at least a week prior to conference through Whova, our conference app. The recorded plenary session content for the online registrants will also be available to in-person participants for 6 months post conference.

Substitution Policy: After the Conference registration deadline a registrant may request the privilege of sending a substitute in their place for an additional \$50 administrative fee.

Switch to Online Participation: If an in-person registrant needs to switch to online participation, please communicate the request in writing no later than Friday, June 3 to the Conference Registrar this requested change. The registrant will be refunded the difference between the in-person package and online package, minus a 15% administrative fee of the original amount paid.

Refund Policy: All ACL Conference registration cancellations and requests for refunds must be made in writing as indicated below. Telephone requests will not be honored.

Before May 13, 2022

To receive a full refund of the conference payments, minus a 15% administrative fee, communicate in writing to the Conference Registrar (confreg@acl.org) your desire to cancel no later than 30 days prior to the first day of the conference {May 13, 2022}.

Between May 13- June 12, 2022

Refund requests submitted fewer than 30 days prior to the start of the Conference will receive a 50% registration fee refund.

June 13, 2022 or after

Requests for refunds received after the first day of the Conference will not be considered except in the emergency situations defined below. Refunds will be sent within six weeks after the conference has concluded.

Emergency Situations

Death of Registrant or Immediate Family Member: Attendees who are unable to attend the Conference due to death must contact the ACL Conference Registrar in writing no later than 30 days after the first day of the Conference to receive a full refund minus a 15% administrative fee.

Sudden Illness or Extenuating Circumstance: Attendees who are unable to attend the Conference due to a sudden illness or extenuating circumstance must contact the ACL Conference Registrar in writing no later than 30 days after the first day of the Conference to have registration switched over to online access. The registrant will be refunded \$100; the remaining registration balance will go towards committed costs for food, lodging, linens, etc.

After July 1

Requests for refunds received later than July 1 will not be honored.

Overpayment Policy: In the case of overpayment of conference fees, overpayments over \$10 will be refunded to the conference registrant upon confirmation by the Conference Registrar. However, if the overpayment amount is \$10 or less, a refund will not be issued and the funds will be donated to ACL Legacy Endowment.

Returned Check Policy: Remittance must be made in U.S. Dollars. A fee in the amount double the amount ACL is charged by the financial institution, plus the original amount of the check will be assessed for a check with insufficient funds. This fee must be paid by money order.
