Background and Description:

Until recently our library employed three professional librarians. Our website and online tutorials were created by another librarian. That individual has recently left for a new position and our institution has decided not to fill the vacancy. The responsibility of creating our online tutorials has now been assigned to me. While our institution is providing access to the software they wish to be used for creating tutorials, I have not had training in how to use the software or in how to create online tutorials.

In looking for training and resources on how to create online tutorials, I have found free training on how to use the provided software. However, I have not been able to locate free training on how to create effective online tutorials. Having watched tutorials from numerous other libraries, I have observed numerous aspects that I like or dislike about various tutorials but those likes and dislikes are based on my personal preferences. In order to create effective tutorials, I would find it useful to obtain professional development that is specific to creating tutorials to be used in a library environment. A librarian whose videos I found useful recommended the course *Creating Effective Online Tutorials* and indicated it was quite useful when updating videos for their library.

The course *Creating Effective Online Tutorials* is a four-week online course that costs \$175. My institution provides limited professional development funds. My institution also feels that access to and training on how to use the software is sufficient training for my new responsibility. In order to take this course, I need to either pay out of pocket or obtain outside funding. Receiving a grant from ACL would allow me to take this course. If I am awarded this grant, I would look forward to sharing videos I create with other ACL libraries for their use and share the knowledge I gain through this course.
